**Scholarship Scheme from NCHMCT, Noida and IHM Hajipur for the year 2021-22 on merit cum means basis for all categories.**

Merit cum Means basis Scholarship shall be provided to One student of 1<sup>st</sup> Semester, 3<sup>rd</sup> Semester and 5<sup>th</sup> Semester of 3 Year B.Sc in H&HA Programme of the Academic session 2021-22 who obtained the highest percentage of aggregate marks, the minimum being 60% (Sixty Percent) in the 1<sup>st</sup> Semester, 3<sup>rd</sup> Semester (In-Institute) and 5<sup>th</sup> Semester examination respectively and the student whose parent's Gross Annual Income from all sources is below 3 Lacs . Such students are hereby directed to collect the "format" with regard to grant of financial Assistance to the Students on merit cum means basis from Administrative section of the Institute or "Download from the website ([www.ihmhajipur.net](http://www.ihmhajipur.net) >Student Zone >Scholarship) and submit the duly filled up format latest by 30<sup>th</sup> April, 2022.

**Following Documents are required to be submitted along with the format:**

- 1) The student should have to submit an AFFIDAVIT on non-judicial stamp paper of Rs. 100/- (Rupees Hundred only) as declaration from their parents regarding;
  - Occupation of the father and mother of the applicant
  - Declaration of Income of Parents from all sources which should not exceed 3 Lacs per annum.
  - That the applicant/ ward has not been receiving any financial assistance support / Assistantship from any State/ Central Govt. Institutions/ Organizations for pursuing the studies for which he/she is enrolled in the affiliated Institute.
- 2) Marksheet of related Semester examination.
- 3) Caste Certificate (in case of reserve category i.e. OBC/SC/ST)
- 4) Valid Income Certificate issued from competent authority (not more than one year)

Under the above mentioned scheme, only 50% of the Tuition fee of respective Semester shall be provided to one student of each semester by NCHMCT and IHM Hajipur jointly. Remaining 50% of the Tuition Fee and other fees shall be borne by the students who fulfill the above mentioned criteria.

Any false and untrue declaration may lead to rustication from the Institute and initiate judicial procedure against them.

The grant of financial assistance to the students should not be taken as claim, as it is subject to fulfilment of conditions.
